



LEGACY AMENDMENT ARTS AND CULTURAL HERITAGE GRANT Como Park Zoo and Conservatory FY 2012/2013 Report Minnesota Legislative Reference Library January 15, 2011 – January 15, 2012

The Minnesota State Legislature approved Minnesota Laws of 2011, Special Session, chapter 6, article 4, Arts and Cultural Heritage Fund appropriations for fiscal years 2012-13: "grants of \$200,000 each year to the Como Park Zoo...for programmatic development."

Como Park Zoo and Conservatory is one of the top visited cultural destinations in the state of Minnesota, with over 2 million visitors each year, because it's free, interactive, welcoming, and accessible for families. Como Park Zoo and Conservatory celebrates diversity in many forms, across cultures, ethnicity, economics and generations and visitors come from all over the state.

Como will create the following projects that will interweave the arts, culture and history into the guests that participate, along with increasing the number of participates and students that are exposed to the arts and culture. The Arts and Cultural Heritage FY 2012 & 2013 grant initiatives represent six projects:

- Music Under Glass & Lecture Series
- Interpretive Signage
- EdZOOcation Programs
- Special Exhibits
- Children's Garden & Formal Garden
- Theatrical Show Presentation

Attached is a summary for each of these projects.

Music Under Glass & Literary Lecture Series

Como Park Zoo and Conservatory offers a unique venue to showcase musicians. These free programs also offer the venue in times outside of the standard public hours and introduce the arts to a new audience. The first series will begin January 12, 2012 and offers six evenings of music featuring local musicians in the Marjorie McNeely Conservatory. A second music series will begin in June 2012. The lecture series will begin in September 2012 and will feature experts in the fields of plant and animal conservation.

Special Exhibits: Como will design, develop and produce a variety of opportunities in seasonal exhibits including *Roots, Shoots and Fruits: The Incredible Edible Garden* and a Bird Aviary. In additional special exhibits in the Gallery will also feature photography and build partnerships to feature exhibitions on topics like bears, wolves, and mushrooms.

- Gallery Exhibits will feature at least four rotating exhibitions beginning in November 2011, focusing on the off-peak season in 8 to 12 week runs.
- Roots, Shoots and Fruits: The Incredible Edible Garden will be featured May 2012-September 2012.
- Bird Aviary work will begin in September 2012 and open May 2013.

Children's Garden & Formal Garden: One project on Como's master plan is the design development of ornamental gardens in the form of a Children's Garden and Formal Garden in front of the Visitor Center. The concept of the Gardens is to provide a central pedestrian mall as the primary organizing element related to the front entrance of Como Park Zoo and Conservatory and the Visitor Center. This includes a formal gardens, path ways, use of water features, seating, and plantings in the form of beds and topiaries. Also identified in this project is the need for better vehicle drop off points for added accessibility to the main entrances. In the meantime, additional resources to construct these gardens will be sought.
