Measurable Outcomes

Community Engagement Project Phase

Proposed Outcomes

1) Forming a Design Advisory Committee establishes a clear process, brings credibility to project, and establishes a conduit to receive approval of preferred artwork for construction.

2) Forming a Design Advisory Committee increases transparency for greater community.

3) A local artist brings cultural expertise and fabrication experience to the project to refine the preferred concept for construction.

4) Approval of a preferred artwork advances the design for fabrication and installation.

Measurement Method

 Form a new Design Advisory Committee (DAC) to advance preferred design of the Hmong Cultural features for construction. Receive feedback through DAC through responses including, but not limited to, public comments, plan reviews, polling questions, and/or participant surveys.
Conduct one or more DAC meetings to receive community feedback on refined art features for fabrication and construction.

3) Local artist(s) to be a familiar with fabrication materials and methods.

4) Refine preferred concept during artwork fabrication and construction phase.

Actual Outcomes Achieved During Fiscal Year

During the fiscal year, the Design Advisory Committee continued and held three meetings to refine art features for fabrication and construction. Work continued with the local artist on design, fabrication, and preparation for commissioning of artwork.

Design and Construction Project Phase

Proposed Outcomes

1) Complete construction of the Hmong Cultural Plaza that includes a physical/artistic element(s) such as Qeej (reed instrument) and necklace that shows the Hmong culture.

2) Complete construction of site features including an irrigation system, plantings and electrical outlets.

Measurement Method

1) Hire artist to complete fabrication and construction of the Hmong Cultural Plaza that includes a physical/artistic element(s) such as Qeej (reed instrument) and necklace that shows the Hmong cultural.

2) Hire contractor to complete construction of site features including an irrigation system, plantings and electrical outlets.

Actual Outcomes Achieved During Fiscal Year

During the fiscal year, the contractor was hired to complete construction of site features including concrete flatwork, sodding, seeding, plantings, irrigation, and electrical. The artist was also hired to begin fabrication and construction of artwork for the Hmong "Mountain Wall" and plaza "Elephant Foot."
