Survey responses at all the author visits demonstrated a very positive, even excited, response to author readings at their local library. Survey results were not only positive regarding the quality of the program, but indicated greater knowledge of the Arts and Cultural Heritage fund. A comment heard most often was "I didn't think that our area would get any benefit from the fund but this is exactly what I'd hoped for". Comments also indicated a higher level of interest in the possibility of further programming at their local library and a more positive attitude to further programming. More than 30 unique author/book-based program ideas were generated

86% of the participants had never been to an author reading or had the opportunity to ask questions about the writing and publishing process and 90% of participants indicated that they now knew more than they had about Minnesota authors.

Although it was not a KRLS program goal, it is worth noting that all authors had books to sell, and all sold out before the end of their tours. Few of our library locations have local bookstores, and this purchase behavior seems to be quite new and initiated by the positive experience at the reading.

Survey responses indicated increased knowledge of how music assists in telling stories. The majority of suggestions for further programs indicated that the "story" aspect of these events was clearly understood because the recommendations were for performers with strong storytelling skills.

91% of the Elisa Korenne survey respondents indicated that they had learned more about Minnesota history in an enjoyable way.

most respondents enjoyed the familiar music more, over 50% appreciated the opportunity to hear a new piece of music composed by a Minnesotan. The most frequent comments were "I never thought that I'd hear the symphony in this town", "please do it again", and requests for a longer program with more shorter pieces of music. Very few people had met a living Minnesota composer, and 80% of respondents in the 4 communities that he visited found it valuable.

If participation by a regional public library system or a member local governmental unit is discontinued, ownership of the discontinuing system's or unit's assets purchased with Arts and Cultural Heritage funds, including cash or the fair market value thereof of such assets cannot be transferred by the applicant and shall revert to the Minnesota Department of Education for reassignment for library services elsewhere. (*Minnesota Rules* Chapter 3530.0200, Subp. 4(C).
- 4. The provisions of Title VI of the Civil Rights Act of 1964, (42 USC Sec. 2000d *et seq.*), its regulations and all other applicable federal and state laws, rules and regulations. (*Minnesota Rules* Chapter 3530.0200, Subp. 4(D).
- 5. That the regional public library system and its branches/members are in compliance with *Minnesota Statutes* 2004, Chapter 134.50 (a) so that all public library computers with access to the Internet available for use by children under the age of 17 must be equipped to restrict, including by use of available software filtering technology or other effective methods, all access by children to material that is reasonably believed to be obscene or child pornography or material harmful to minors under federal or state law, and section (c) so that the library prohibits, including through the use of available software filtering technology or other effective methods, adult access to material that under federal or state law is reasonably believed to be obscene or child pornography.
- 6. That the regional public library system and its branches/members are in compliance with *Minnesota Laws* 2000, Chapter 492, Article 1, Section 49, Subd. 5A, and has adopted a policy to prohibit library users from using the library's Internet access workstations to view, print, or distribute material that is obscene within the meaning of *Minnesota Statutes* 1998, Chapter 617, Article 241
- 7. An independent auditor's report of the systems' general purpose financial statements in accordance with generally accepted auditing standards and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States shall include audit of the Arts and Cultural Heritage funds as a unique categorical fund account. The audit shall be submitted no later than 180 days after the close of the system's fiscal year. (*Minnesota Rules* Chapter 3530.1200).
