#### **INTRODUCTION**

In 2008, the Clean Water, Land and Legacy Amendment to the Minnesota Constitution, called the "Legacy Amendment," was approved by Minnesota voters to: protect drinking water sources; to protect, enhance, and restore wetlands, prairies, forests, and fish, game, and wildlife habitat; to preserve arts and cultural heritage; to support parks and trails; and to protect, enhance, and restore lakes, rivers, streams, and groundwater. The Legacy Amendment increased the state sales tax by three-eighths of one percent from July 1, 2009 through 2034. This sales tax revenue is distributed into the Legacy Amendment's four funds as follows: 19.75 percent to the Arts and Cultural Heritage Fund, 33 percent to the Clean Water Fund, 33 percent to the Outdoor Heritage Fund, and 14.25 percent to the Parks and Trails Fund. The Lake Superior Zoological Society (Society) has received funding for several programs and projects from the Legacy Amendment's Arts and Cultural Heritage Fund (ACHF). The ACHF supports arts, arts education and arts access, and preserves Minnesota's history and cultural heritage.¹

# **Appropriations, FY 2020 and FY 2021**

For the State of Minnesota's Fiscal Year (FY)<sup>2</sup> 2020-2021 biennium<sup>3</sup> a total of \$150,000 was appropriated to the Society from the Legacy Amendment's ACHF. Pursuant to 2019 Minnesota Session Laws, 2019 Special Session, Chapter 2, Article 4, Section 2, Subd. 6, "\$75,000 each year is to develop educational exhibits and programs." According to the "Arts and Cultural Heritage Fund Grant Agreement for the Lake Superior Zoological Society Project" (Contract #164997 PO #300-8901) between the Society and the Minnesota Department of Administration, effective July 1, 2019:

Under the provisions contained in the aforementioned 2019 Minnesota Session Laws, the State of Minnesota has allocated \$75,000 in fiscal year 2020 and \$75,000 in fiscal year 2021, less 3% each FY for the State Entity's administration costs, for a total of \$145,500, which is given to the Grant Recipient as a grant for use of this project.

<sup>&</sup>lt;sup>2</sup>The Minnesota state budget fiscal year (FY) begins on July 1 and ends on June 30 of the following year and is designated by the year in which it ends. Thus, FY 2020 begins July 1, 2019 and ends June 30, 2020.

<sup>&</sup>lt;sup>3</sup>The Minnesota state budget operates on a biennium, which is a budget cycle covering two fiscal years. A biennium begins on July 1 of odd-numbered years. Thus, the FY 2019-2020 biennium begins July 1, 2019 and ends June 30, 2021.

#### Reporting

As a recipient of funds from the ACHF, the Society must abide by certain reporting requirements as stated in Minnesota Statutes § 3.303, Subd. 10, and § 129D.17 Subd. 2 (d). According to Minnesota Statute 129D.17, Subdivision 2(d):

A state agency or other recipient of a direct appropriation from the arts and cultural heritage fund must compile and submit all information for funded projects or programs, including the proposed measurable outcomes and all other items required under section 3.303, subdivision 10, to the Legislative Coordinating Commission as soon as practicable or by January 15 of the applicable fiscal year, whichever comes first. The Legislative Coordinating Commission must post submitted information on the Web site required under section 3.303, subdivision 10, as soon as it becomes available.

The report of projects funded with ACHF appropriations must contain the following information:

- 1. The name of the project and project description;
- 2. The name, telephone number, members of the board or equivalent governing body, and e-mail address of the funding recipient and, when applicable, the Web site address where the public can directly access detailed information on the recipient's receipt and use of money for the project;
- 3. The amount and source of funding, including the fiscal year of the appropriation;
- 4. The amount and source of any additional funding or leverage;
- 5. The duration of the projects;
- 6. The number of full-time equivalents funded under the project;
- 7. The direct expenses and administration costs of the project;
- 8. Actual measured outcomes and evaluation of projects as required by statute; and Specific information for each program produced and broadcast, including the cost of production, the number of stations broadcasting the program, estimated number of listeners, and other related measures. If the programs produced include educational material, the noncommercial radio station must report on these efforts.

The report must be submitted by January 15 to the Minnesota Department of Administration, the Legislative Coordinating Commission, and the chairs and ranking minority members of the Senate and House of Representatives committees and divisions having jurisdiction over Arts and Cultural Heritage policy and finance.

This document covers the Fiscal Year 2020 reporting period of July 1, 2019 to June 30, 2020.

#### **Measured Outcomes and Evaluation**

Goal: To create an engaging and renovated exhibit featuring North American gray wolf within its native habitat related to its natural challenges and opportunities. The exhibit will increase awareness of conservation issues the gray wolf faces, as well as provide an opportunity to understand how the wolf fits within our various regions. This exhibit will meet the Association of Zoos and Aqauriums (AZA) standards and random visitor evaluations will continue.

*Progress:* The Lake Superior Zoo has achieved the proposed and stated measurable outcomes of the FY20 appropriation of this grant, which was to develop an engaging exhibit through working with vendor(s) to improve habitat enclosures, repairing damaged sections of fencing and guest walkways, and monitoring and completing internal habitat features.

The Lake Superior Zoo contracted with Keller Fencing to repair the damaged fencing around the existing exhibit located on the hillside directly across from Kingsbury Creek within the zoo's perimeter. Zoo staff then completed the interior exhibit work by purchasing the necessary supplies to ensure the habitat met AZA standards for North American gray wolf exhibits. In accordance with legislation passed extending the grant deadline for FY20, the Zoo has a remaining balance to spend on supplies and will do so by June 30, 2021.

The FY20 grant appropriation encompassed revitalization of an existing gray wolf exhibit to provide engaging interpretation relative to the species and its conservation.

The exhibit is now home to three gray wolves, Sierra, Tehama, and Shasta, that arrived at the Lake Superior Zoo in November. Current feedback from visitors has been overwhelmingly positive and the Zoo will continue to monitor random guests for responses to the imporved habitat as it relates to education and engagement.

Overall, the North American gray wolf exhibit has been a wonderful addition and achieved success through meeting goals and realizing our proposed outcomes. The Lake Superior Zoo wishes to express their gratitude to the Legislative Coordinating Commission, the Senate Environment and Natural Resources Policy and Legacy Finance Committee, the House Legacy Funding Finance Committee, and the Department of Administration for their support in this project.
