Jon Oyanagi opened the meeting and led the introductions. Welcome to all new & returning members, Liaisons, and staff to the first PTLAC Meeting of 2021! A special thanks to all those that are able to attend today's meeting.

The December 3rd PTLAC Meeting Minutes have been approved.

Introductions & Ice Breaker Activity:

In an effort to continue learning and connecting with each other in a virtual world, Jon Oyanagi led a brief "ice breaker" activity, known as "two truths and a lie." Thank you all for indulging in this casual activity as a means to connect, and to get to know each other more.

Implementing Agency Reports: Looking Forward with Legacy Funds

The Legacy Liaisons began by sharing their Agency's plans for Legacy Funds in FY 2022 & 2023.

Greater Minnesota Regional Parks and Trails Commission: Renee Mattson

Renee Mattson led the first presentation of this meeting by describing the future funding plans for Greater Minnesota Regional Parks and Trails.

- Each year, the GMRPTC opens a competitive grant process beginning April-July
- All regionally designated systems are eligible to apply for this grant funding
- GMRPTC is made up of 64 Regionally Designated Parks and Trails across 80 Counties in MN
 - o 21 Regional Trails
 - o 31 Natural Resource Based Parks
 - 12 Special Recreation Feature Parks
 - Northland Regional Sports Park & Sandstone Robinson Park are good examples of these unique parks in Minnesota
- The recommendation selection process begins with determining eligibility, which is established by regional designation of a park, trail or other recreation feature
- Once a system has been regionally designated, they are eligible to apply for a grant, which is administered by GMRPTC
- GMRPTC receives 20% of the total Parks and Trails Legacy Fund each fiscal year
- This agency utilizes an Evaluation Team (ETeam) to provide general review and feedback to the Commissioners, which is based on a competitive scoring process
- The Commission reviews and discusses the applicants and determines final funding recommendations to the Legislature
- The Legislature has the final ability to review & approve these recommendations
- Highlight of current proposed projects for the upcoming fiscal years:
 - Sandstone Robinson Park
 - Olmstead County Oxbow Park and Zollman Zoo
 - Goodhue County Byllesby Park
 - o Otter Tail County Perham to Pelican Rapids Regional Trail
 - o Mesabi Trail
 - Lake County Mountain Bike Trails
 - o Gull Lake Trail
 - Moorhead River Corridor Trail
 - Chisago County Sunrise Prairie Trail
 - Wright County Connecting People with the Outdoors
 - Luverne Loop & Blue Mounds Trail
 - Winona Bluffs Traverse

Metropolitan Council: Emmett Mullin

Emmett Mullin continued by sharing an overview of the Metropolitan's Regional Park System.

- The Metropolitan Council receives an appropriated amount for each biennium, which is allocated based on a statutory formula
- The estimated funding for the 2022/2023 biennium is approximately \$38 million.
- 10% of the Parks and Trails Legacy Fund is set aside for the Park Acquisition Opportunity Fund
- The Metropolitan Council doesn't own or operate any of the regional parks/trails; the 10 Implementing Agencies operate their respective regional system independently

- The 25-Year Parks and Trails Legacy Plan's 4 pillars frame much of the work of the Metropolitan Council:
 - Connecting People to the Outdoors
 - Acquire Land, Create Opportunities
 - Taking Care of What We Have
 - Coordination Amongst Partners
- Thrive MSP 2040 and the Regional Parks Policy Plan are strategic documents that also guide the Metropolitan Council's work
- Stewardship, Prosperity, Livability, Sustainability and Equity are outcomes that were introduced in 2014
 - Equity means connecting all residents to opportunity, including ensuring equitable access to regional parks and trails
 - o Equity is a central focus for much of the Metropolitan Regional Parks System's work
- Fiscal year 2022/2023 Project by Legacy Pillar:
 - 21 projects are devoted to Taking Care of What We Have
 - o 15 are working on Acquiring Land, Creating Opportunity
 - 13 are focused on Connecting People and the Outdoors
- Equity Highlights:
 - o Anoka County: Rice Creek Chain of Lakes
 - o Bloomington: Bush Lake Piers
 - o Carver County: System-wide Outreach work
 - o Dakota County: System-wide Outreach work
 - o Minneapolis: North Mississippi Regional Park
 - Ramsey County: System-wide Outreach and Programming
 - St. Paul: Lake Phalen East Shore Trailhead
 - Scott County: Spring Lake Regional Park
 - Three Rivers Park District: Mississippi Gateway Regional Park
 - o Washington County: Point Douglas Regional Trail & Park Building Improvements

Minnesota Department of Natural Resources: Erika Rivers

Erika Rivers continued the discussion by sharing the plans for 2022/2023 Legacy Funds within the Minnesota DNR's State Parks and Trails System.

- Minnesota State Parks and Trails System Overview:
 - 75 State Parks and State Recreation Areas
 - 5,000 camping and lodging units
 - 240,000 acres of land managed
 - o 25 State Trails
 - 1,500 miles of developed state trails
 - 3,600 miles of hiking, biking, horse and motorized trails
 - 24,600 miles of Grant-in-Aid Trails (snowmobile, OHV, and ski)
 - 43 State Forest Campgrounds
 - 12 state forest horse campgrounds
 - 29 forest day-use areas
 - 35 State Water Trails

- 1,700 public water accesses
- 360 fishing piers
- 10-Year MN DNR Parks and Trails Legacy Appropriations (by Legacy Pillar)
 - 17% Connect People to the Outdoors
 - o 26% Acquire Land, Create Opportunity
 - o 56% Take Care of What We Have
 - 1% Coordinate Among Partners
- Fiscal Year 2022/2023 MN DNR Parks and Trails Legacy Proposal (by Legacy Pillar)
 - o 21.5% Connect People to the Outdoors
 - o 17.5% Acquire Land, Create Opportunity
 - o 61.0% Take Care of What We Have
 - Funding for the Coordination Among Partners is appropriated separately from the DNR's Legacy Budget
- Coordination Among Partners (approx. 1%)
 - Parks and Trails Legacy Advisory Committee
 - Provides guidance on Parks and Trails 25-Year Plan
 - Guides collaborative efforts toward joint outcomes
 - Joint Projects for Shared Outcomes
 - Connecting people to a seamless system- MN Great Outdoors Website & maintenance
 - Research:
 - Collaboration with University of MN
 - Developing joint research efforts based on new technologies
 - Restoration Evaluations:
 - Legislatively mandated to ensure effective natural resources restorations
- Connecting People to the Outdoors (21.5%)
 - I Can!- outdoor skills programs for beginners
 - Over 50% of BIPOC participating in this program
 - o Urban Outreach Program
 - Focused marketing and content placement
 - o Multi-cultural competence building among Parks and Trails Division Staff
 - Mutually beneficial, multi-cultural partnerships across all 10 districts
 - New: Updated Wayfinding/Point-of-Arrival
 - New: Social Media Influencer Pilot
- Acquire Land, Create Opportunities (17.5%)
 - Acquire Land (36%)
 - Create Opportunities (64%)
 - Cuyuna State Recreation Area & Trail development, Itasca State Park safety improvements, and Whitewater State Park accessibility improvements
- Taking Care of What We Have (61%)
 - o General natural resource management projects
 - o Prescribed Burning Program to restore native prairies and control invasive species
 - Rehabilitation of existing facilities
 - Hiking trail sustainability & erosion control

- DNR Parks and Trails Legacy Investment Process
 - Review Outcomes & Alignment (March-June)
 - Set New Priorities & Objectives (June-September)
 - Develop Project List (September-November)

Comments & Questions from PTLAC Members:

- What other trends, aside from Equity, are all three systems looking at?
 - O Understanding what is a fad, vs. what is a trend is important
 - When there are new fads, which are (or are not) appropriate for outdoor recreation facilities?
 - Example: Frisbee golf
 - Mountain Biking is a current trend, that all systems are working on accommodating
 - Mountain biking trends have increased over the years for all three systems, especially since the development of Cuyuna's Trail System
 - In terms of equity, access to mountain biking equipment is becoming more and more expensive, making this trend financially inaccessible to many
 - Focusing on different types of trails, from beginner to expert level, is a priority for Greater Minnesota
 - o In Greater Minnesota's system, the Commission relies on their regional systems to determine these trends & make project proposals accordingly
 - Climate change is another important trend, especially for the Metropolitan Council's systems, and it carries implications for managing parks systems
 - Parks and Trail systems are engaged in difficult water management conversations across the 10 Implementing Agencies
- How can the work of the PTLAC Subcommittees best serve the Implementing Agencies in their work?
 - Being intentional, and giving space and time for PTLAC members to begin working on & finalizing Subcommittee work products
 - Focusing on practical, tangible recommendations for the Benchmarks Subcommittee is a specific goal
 - This discussion will be continued at the Subcommittee Work Planning Session, later this afternoon

Virtual Tour of Lake Vermillion Soudan Underground Mine:

Erika Rivers shared a brief overview of the virtual tour of Lake Vermillion Soudan Underground Mine State Park, which was acquired with Legacy Funds.

- Margaret Krueger briefly shared a quick video-tour of Soudan Underground Mine before moving onto the rest of the tour
- Soudan Mine is one of the many unique jewels in Minnesota's Parks and Trails System, which many people don't know about
- In 2010, a piece of property (Lake Vermillion) that was held by the mining company, was acquired, which was near Soudan Mine
 - This land that was acquired was combined with Soudan Mine State Park, which is now known as Lake Vermillion Soudan Mine State Park

- This land was acquired with Parks and Trails Legacy Funds
- o Together this park is about 6,000 acres, with 10 miles of protected shoreline
- The Underground Mine housed a neutrino experiment, led by the University of Minnesota
 - This laboratory experiment has since been concluded
 - This project involved sending neutrinos underground from the University of Illinois, and finding subatomic particles at this location in Minnesota
 - Arts to Parks investments were a major focus of this project, and a commissioned painting was on display throughout the duration of this project.
- The Lake Vermillion Visitors Center is within a historical dry house, and will hopefully be updated in the future
 - "touch & see" exhibit developments are on pause right now due to the spread of COVID 19
- Soudan Mine is also home to many bats, which are being negatively affected by white-nose syndrome
 - Hundreds of thousands of bats were found to be dead, which led to the discovery of this syndrome in Minnesota's bat populations
- Lake Vermillion Soudan Underground Mine is home to about 130 historical boat houses, which were built in the 1930s, 1940s, and 1950s
- Lake Vermillion is culturally, and archeologically, significant, based on the establishment of centuries-old indigenous trade routes
- The DNR consults heavily with the Boise Forte Band of Ojibwe to preserve this traditional knowledge & ensure best cultural practices are valued
 - The DNR hosts an annual "Pontoon Ride", which is held in partnership with the Boise Forte Band of Ojibwe
 - This is a chance for indigenous elders to offer cultural blessings to significant areas of Lake Vermillion
 - This area was mined for many centuries, and chert was one of the products that indigenous communities held as culturally significant
 - A fire ring site was also found, which has deposits of obsidian; this is evidence of early trade established between what is now Minnesota, and the Yosemite/Glacier National Park area of the country

Funding Workgroup Updates:

- Governor Tim Walz released his budget proposal on Jan 26th, which outlined the same funding allocations for the Parks and Trails Legacy Fund: 40% to DNR, 40% to the Metropolitan Council, and 20% to GMRPTC

- The PTLAC has been asked to draft a letter of support for these funding recommendations, which will be sent to leadership on the Senate and House Legacy committees in the Minnesota State Legislature.
- Is it outside of our purview for this group to recommend more funding for Greater Minnesota?

- Currently, the recommendation of leadership from all implementing agencies (including GMRPTC) is that the funding allocations remain the same (40-40-20)
- The operating budget of the Commission is taken out of the 20% of Legacy Allocations that are available for granting to Greater Minnesota's regionally designated systems, who does not receive any additional sources of funding.
- GMRPTC is hoping that this operating budget will be absorbed as a line-item in the Governor's budget proposal, (a total of \$900,000) which would free up more funds to be available for Legacy projects in GMRPTC's system in the future
- The draft letter of support has been approved by group consensus
- DNR staff will follow up & send the letter of support to leadership on the Senate and House Legacy committees in the Minnesota State Legislature.

Subcommittee Updates:

The PTLAC continued by completing small-group breakout meetings for each subcommittee. The following is a summary of these breakout sessions.

Benchmarks Subcommittee:

- This subcommittee is close to finalizing a template, which outlines reporting templates for the Implementing Agencies
- This template will be used in time for the next reporting cycle: 2022
- A focus on the quantitative methods of reporting is also a priority for this group
- This subcommittee should meet within the coming months to finalize this work further

Communications:

This subcommittee did not meet today, because other members were attending other subcommittee breakout sessions. DNR staff will follow up on scheduling another meeting for this subcommittee.

Governance:

- This subcommittee discussed their work plan for this year:
 - 1. Explore past work of previous Governance Subcommittee work
 - 2. Review the charter, policies and procedures and update anything needed
 - 3. Review the charter, policies and procedures with an equity lens
- Reviewing the membership recruiting process and making sure this is an equitable and fair process for all
- Reviewing agency governance issues, and providing advice as appropriate on the issues mentioned above
- Lars will follow up with the Governance & Inclusion Subcommittee and send the Draft Guidelines for Advisory Groups, which the DNR uses to provide guidance on equity issues within advisory groups
- This subcommittee will meet before the April 22nd PTLAC meeting

Inclusion:

This subcommittee will focus their efforts over the next two years on the following goals:

- By December, 2022, provide Minnesota Parks and Recreation Agencies with information directly from underrepresented groups that are experiencing barriers to outdoor recreation
 - Strategy: hosting a series of meaningful dialogue with these groups & pairing
 this information with qualitative & quantitative research methods (focus groups,
 surveying, demographics research etc)
 - 2. End goal: Providing a complete report on the barriers that are currently being experienced, and a suite of recommendations based on these findings for the Implementing Agencies & their partners
- This subcommittee will meet before the April 22nd PTLAC meeting

Statewide Trails:

- The Statewide Trails workgroup has been very active in their current work, whose goal is to complete a statewide trail in Minnesota
- The mission statement has been reviewed by the Legacy Liaisons, and the next step is to seek final approval from the PTLAC at the April 22nd meeting
- The workgroup is currently drafting search corridors to define a general trail route, which is an ongoing process
- This workgroup will meet again in the coming weeks, before the April 22nd PTLAC meeting

Final Updates:

Legislative & Agency Updates:

- A number of presentations have been given by the Implementing Agencies to the Legislature;
 topics included:
 - o COVID-19 Impacts on Parks and Trails
 - o Impact of Diversity, Equity, and Inclusion in Parks and Trails Systems
 - o 2022/2023 Budget Plans

Outdoor Recreation Task Force Updates:

- The Minnesota Outdoor Recreation Task Force completed a first draft recommendations document on the issue of opening a Minnesota Office of Outdoor Recreation
- These draft recommendations have been made public, and the task Force opened a period for public comments, which closed on Feb. 15th
- Thank you to all PTLAC members that took the time to comment on these draft recommendations
- The Task Force will meet again in March to finalize these recommendations and complete this work
- DNR Staff will follow up with notifying the PTLAC when these final recommendations become public
